PUBLIC CONSULTATION NO.3 - HIGH STREET DOUBLE YELLOW LINES

SUMMARY

Following several reported community concerns regarding inconsiderate parking on the High Street; Barrow Upon Humber Parish Council have expressed the issues to North Lincolnshire Council and therefore, North Lincolnshire Council are proposing to introduce double yellow lines along the High Street in the areas that are referred to as 'pinch points'.

REPORTED CONCERNS

- As a main bus route for several buses, the inconsiderate parking often results in buses not being able to continue their normal route and more often causes delays to their schedule
- Larger vehicles such as vans and delivery vehicles are often unable to reach their desired destination along with High Street
- Parked vehicles have been subjected to damage caused by vehicles trying to access the High Street
