## PUBLIC CONSULTATION NO.2 - INSTALLATION OF A MILESTONE ISLAND

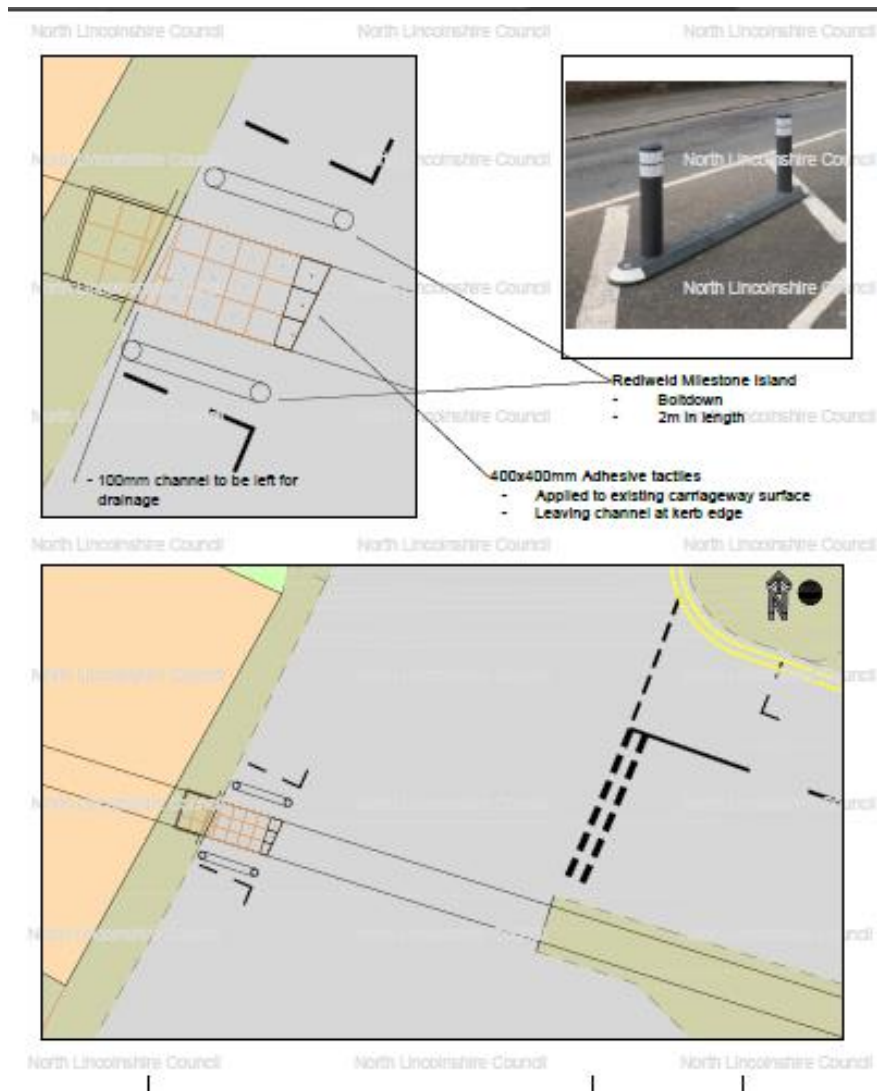
### SUMMARY
